On June 16, 2010, the SCBA Board of Directors voted unanimously to support the following resolution:

AFFIRMING SUPPORT FOR THE BROOKHOLLOW PUBLIC IMPROVEMENT DISTRICT (PID)

WHEREAS, this Texas non-profit corporation was established in 2003 to encourage the establishment of the Brookhollow Public Improvement District (PID) by area property owners and the City of Dallas with a focus of landscaping and ongoing maintenance at entry points;

WHEREAS, a total of \$53,500 has been contributed to Brookhollow PID, Inc., to date to aid in covering expenses to set up the Brookhollow Public Improvement District and to make improvements as examples to other property owners and tenants of what can occur with their support and participation;

WHEREAS, the Directors of Brookhollow PID, Inc. are in the process of contacting 2025 additional 'major' Brookhollow property owners to ask if they share the objective to establish the PID and ask for their financial support with a gift of \$5,000 each;

WHEREAS, if the 'majority' of property owners agree and financially support the PID, then the Directors will proceed with obtaining signatures on petitions of the owners of at least 60% of the appraised value of the properties within the Brookhollow area and the owners of either at least 60% of the land area or at least 60% of the number of properties in order to create the Brookhollow Public Improvement District;

NOW, THEREFORE, BE IT RESOLVED THAT THE Stemmons Corridor Business Association unequivocally supports the efforts of Brookhollow PID, Inc. Directors for the creation of the Brookhollow Public Improvement District.
